





The major requirement of any regulatory section is E-Signature for electronic records, for closed systems (where access is controlled by the persons that are responsible for the content of the electronic records) including authenticity, integrity, confidentiality and non-repudiation. The requirements for open systems (like the Internet) cover electronic records from the point of their creation to the point of receipt and also call for authenticity, integrity and confidentiality, as well as additional measures such as encryption and digital signatures (defined as cryptographically-based).
